### **EXCLUDED ACTIVITIES POLICY**

### **OBJECTIVES:**

- To define the list of activities which are out of the scope of the Company
- To set the activities that the Company can perform
- To set the transactions or relationships that the Company can enter into

# **RECIPIENTS:**

- All employees of ARISE IIP, of its subsidiaries
- All stakeholders of ARISE IIP, of its subsidiaries

Arise Integrated Industrial Platforms and each of its subsidiaries (hereafter referred as "Arise IIP" or the "Company") shall (i) not perform any of the excluded activities as listed below or (ii) enter into transactions or business relationships with any person performing any of the excluded activities:

- Forced labour or child labour.
- Activities or materials deemed illegal under host country laws or regulations or international conventions and agreements, or subject to international phase-outs or bans, such as:
- (a) Ozone depleting substances, PCB's (Polychlorinated Biphenyls) and other specific, hazardous pharmaceuticals, pesticides/ herbicides, or chemicals.
- (b) Wildlife or products regulated under the Convention on International Trade in Endangered Species or Wild Fauna and Flora (CITES); orc. Unsustainable fishing methods (e.g., blast fishing and drift net fishing in the marine environment using nets surpassing 2.5km in length).
- Cross-border trade in waste and waste products unless compliant to the Basel Convention and the underlying regulations.
- Destruction of High Conservation Value areas
- Radioactive materials and unbounded asbestos fibres.
- Pornography and/or prostitution
- Racist and/or anti-democratic media.
- In the event that any of the following products form a substantial part of a company's primary operations, or a financial institution, investment fund or company's financed business activities:
  - (a) Alcoholic Beverages (except beer and wine)
  - (b) Tobacco,
  - (c) Weapons and munitions, or
  - (d) Gambling, casinos and equivalent enterprises.



# Industries in high pollution category including but not limited to Air, Water and Hazardous waste

The following industries are required to do an ESIA (Environment and Social Impact Assessment)
The listed industries after successful completion of ESIA, shall be considered based on approvals from Legal,
ESG and Business Development department.

- 1. Recycling / reprocessing/ recovery/reuse of Hazardous Waste containing zinc, nickel, arsenic, vanadium, cobalt, mercury, lead, polychlorinated biphenyl.
- 2. Diesel Generator Manufacturing
- 3. Industrial carbon including electrodes and graphite blocks
- 4. Phosphate rock processing plant
- 5. Manufacturing of Sugar
- 6. Firecracker manufacturing and bulk storage
- 7. Phosphorus compounds
- 8. Explosives, Detonators, Fuses including managing and handling activities
- 9. Organic Chemical Manufacturing
- 10. Asbestos based industries
- 11. Chlorates, pre-chlorates and per oxides
- 12. Chlorine, fluorine, bromine, iodine and their compounds
- 13. Nuclear Power Plant
- 14. Manufacturing of Pesticides
- 15. Manufacturing of Photographic film and its chemicals
- 16. Railway locomotive workshop
- 17. Chlor-Alkali units
- 18. Ship breaking industries
- 19. Oil and gas extraction
- 20. Aluminium Smelter
- 21. Copper Smelter
- 22. Zinc Smelter
- 23. Pulp and paper manufacturing
- 24. Distillery (molasses/ grain/yeast based)

Any other potentially high polluting industry both in air and water and/or hazardous waste generation will be excluded unless there is a detailed pollution prevention plan to minimize the pollution to near zero levels by use of technology advancement or innovation. They shall be considered on its merit and case by case basis.
